

On September 30, 2022 Impinj began the end-of-life (EOL) process for the Impinj Indy R2000 and Impinj R500 reader chips. This Product Notice sets the official timeline for the end of production of the Impinj R2000 and the Impinj R500 reader chips.

The objective of providing this notice is to allow for appropriate planning, the opportunity to place last-time-buy orders, and to provide details about alternative products from Impinj and Impinj partners for your consideration.
